(2) The Real Time Price (RTP) includes the PJM real time hourly price with a correction for losses based on customer voltage level, the customer specific capacity value, administrative charges, over/under collection amounts from the previous period determined by the Company's monthly reconciliation process and applicable GRT.

(3) The Transmission Service Charge (\$/kW) for the MT1 (LP5) class was updated to be \$56.378 for the period of July 12, 2025 through November 30, 2025 via filing made on June 12, 2025.
