(3) The GSC and the TSC reflect the statutory PA Gross Receipts Tax (GRT) of 5.9%. The State Tax Adjustment Surcharge (STAS) reflects the incremental GRT pursuant to 72 P.S. § 8111-A(d) less any applicable refunds (-0.284%).

(4) The Real Time Price (RTP) includes the PJM real time hourly price with a correction for losses based on customer voltage level, the customer specific capacity value, administrative charges, over/under collection amounts from the previous period determined by the Company's monthly reconciliation process and applicable GRT.

(5) In this edition of the Price to Compare, all of the sub-classification of the rates utilized in PPL EU billing system have been added.
